Tenderers and all parties constituting the Tenderer shall not have a conflict of interest pursuant to Rule 55 of the Public Procurement Rules, 2008.</li> <li>3. Only Bangladeshi tenderers are eligible.</li> <li>4. Tenderers shall not be insolvent, shall not be in receivership, shall not be bankrupt, shall not be in the process of bankruptcy, shall not be temporarily barred from undertaking business and it shall not be the subject of legal proceedings for any of the foregoing.</li> <li>5. Tenderers shall have fulfilled its obligations to pay taxes and social security contributions under the provisions of laws and regulations of the country.</li> <li>6. These requirements for eligibility will extend, as applicable, to the Sub-contractor(s) proposed by the Tenderer.</li> <li>7. The Tenderer should have preferably 15 years of experience in making film/documentary.</li> <li>8. The Tenderer should own/possess well equipped laboratory facilities for keeping video records of 4K resolution, high quality and capacity movie cameras, and high quality drone for best quality video.</li> <li>9. The Tenderer should have at least one experience of making audio visual production with Bangladesh Government within last 2 years.</li> <li>10.
