Could you please clarify that a consortium comprising local and foreign entities constituted by means of a joint venture consortium agreement and not registered with the RJSC can submit an application under the Tower Sharing Guidelines, provided it submits an undertaking that it will convert into a company registered with the 	Responses It is not mandatory for the applicant to register in the RJSC before submission of application. The applicant may form a company including the local partner before submission of the application. In this regard, all the company documents (Certificate of Incorporation, MoA, AoA, Form-XII) shall have to be submitted by the applicant. In case of consortium, the foreign and local partners may execute an Agreement among themselves according to the percentage of shareholding as specified in the Guidelines before submission of the application. In this regard, the copy of the Agreement in non-judicial stamp, all the company documents and board resolution of the shareholding companies shall have to be submitted by the applicant. The applicant shall mention a proposed company name in the agreement and submit a name clearance certificate issued from the RJSC. The applicant shall have to form a company under the law(s) of Bangladesh
